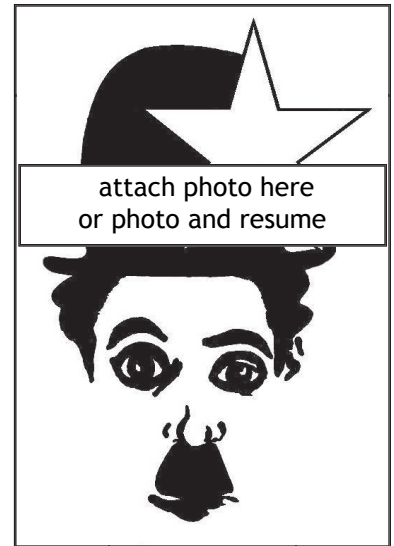

**PIONEER PLAYHOUSE  
STUDENT INTERN RULES & REGULATIONS**

The term **student intern**, as defined by Pioneer Playhouse, is “one who is bound by contract to perform and serve for a prescribed period while learning stagecraft by practical experience in all phases of theatre.”

You will be regarded as a member of a professional acting company. Your actions, both moral and professional, will reflect the name and policy of this theatre. Therefore, you will be expected to conduct yourself with dignity and discretion at all times and abide by general management regulations, which have been set down for harmonious relations between all.

**PIONEER PLAYHOUSE RULES AND REGULATIONS:**

1. During the eight week Internship Program, all interns are under the jurisdiction of the Producer, Artistic Director, Director, Technical Director and Playhouse Management Staff.
2. Interns are encouraged to audition with the professional acting company every two weeks and may occasionally land small acting parts in Mainstage shows. In addition, classes are provided in scene study, monologues, basic acting, acting for camera, etc.
3. Interns must be prompt for call times for rehearsal, performance, ‘strike night’ and all tech calls and classes. Work calls for the entire company are 9am- 3pm and 7pm-10:30 pm six days a week (Monday through Saturday), with every other weekend off and one hour mealtime breaks.
4. Interns are expected to perform theatre related duties as assigned by the director, such as: ushering, backstage tech work, costuming, props, lights, sound, stage managing, front of the house duties and/or box office.
5. Drinking, usage of drugs or conducting one’s self in an obnoxious manner on grounds of Pioneer Playhouse constitutes a breach of this agreement. All company members will be expected to retire by 2:30 a.m. and abide by rules governing the use of facilities on property. Frequent and regular late night partying is not permitted and is a breach of contract.
6. Depending on age,(and/or during weeknights) interns are not permitted to leave Playhouse grounds after-hours without Management Permission.
7. Interns are not to bring outside friends to socialize on theatre grounds. Visitors are not allowed to spend the night on theatre property.
8. Pioneer Playhouse agrees to provide room and board for eight weeks. Three meals a day (including beverages and dessert) will be served six days a week. No food is served on Sunday. Breakfast is continental, prepared hot meals are provided for lunch and supper. Interns and all company members must take (the majority) of meals together in the communal dining area.
9. There will be no reimbursement for meals that an Intern eats off the grounds, or for a specialized diet.
10. Pioneer Playhouse will not be responsible for stolen or damaged personal items.
11. Pioneer Playhouse reserves the right to use pictures of its Company Members for publicity purposes on radio, print, TV-- now and in the future.
